Alleviating frustration and arming you with the real-time data needed to feel confident you're turning "time" into profit.

Evaluation Methods Used:

Dovico Timesheet was evaluated using ChromeVersion 128.0.6613.120 on a Windows 11 desktop computer. Assistive technologies used in this evaluation included **AxeDevTool, INCLUDIA, Lighthouse, NVDA (screen reader)** and the Windows screen magnification function as well as exclusive use of the keyboard to navigate and operate the site content and functionality.
